

ertrude 'Gertie' (Baum) Schloss was the first of Israel and Lena's children. She was attractive and very articulate. She married Dr. Abe Schloss and lived in New York, but he died six years later. We are told that he tended his patients day and night, seven days a week, and one day he collapsed as he was running up the steps of a tenement on the Lower East Side. Two sons, Herbert and Lester Abram, resulted from this marriage. Gertie then married Abe's brother, Sol Schloss, and lived in Baltimore, Maryland, where Minna was born.


Gertie was a typical Baum with a delightful sense of humor. Although she suffered from a cardiac condition for many years, she outlived both husbands and saw all her children happily married. She spent her last days with her daughter Minna in Norfolk, Virginia.

Herbert Schloss lived in Baltimore all his life. He had a writing career and, among other things, created innumerable radio scripts. He married Marie Gomprecht. Their daughter Peggy married Mark Goldwater, a member of the family of former Senator Barry Goldwater.

Lester Schloss was an engineer and also lived in Baltimore. He married Bertha Lazaron and they had a son and a daughter, Lester Jr. and Alice Lazaron.

Lester Schloss Jr. was a real estate broker in Baltimore. He married Bonnie Maisel and they had a daughter, Leslie Inge, who married Martin D. Allen and had two children, April Inge Allen and Martin D. Allen Jr.

Alice (Schloss) Gamse married Howard Gamse, a graduate of Kutztown College in Pennsylvania with a degree in art education. He went into his family's business, Gamse Lithography. 

melia 'Millie' (Baum) Geigerman was bright and amiable. She was born in Oil City, Pennsylvania, where her father was nurturing an oil well and tending his dry goods store. She had a talent for painting, and worked on several large canvasses clandestinely. hiding them in the attic. On New Year's day she brought her parents up to the attic and displayed her paintings. Her father stood there and wept.

Millie married Harry Geigerman and they joined her father in Rockdale, Texas, where Harold was born. Later, they moved to Chicago and then returned to New York where Hazel was born. Millie, like her mother, lost several small children - Edith, Everett and Irwin. Two of them died of dyphtheria over a single weekend after their brother Harold came home with a sore throat. We were told the poignant story of how Millie cherished a small blackboard on which one of the little girls had scrawled a drawing in chalk. Millie never parted from it.

She died soon after celebrating her 90th birthday with a large reception for relatives and friends. She attended meetings of her favorite organization, the Guardian Mothers League (of which she was recording secretary), until the age of 87. Her recorded minutes were a delight to listen to. She never missed her Friday luncheon and bridge date until she became too ill to go out. She shared her apartment with her daughter Hazel, who was a dedicated daughter and companion until the last minute. Harold, too, was exceptionally devoted to his remarkable mother, an outstanding member of our family.

Harold Geigerman was born in Rockdale, Texas, but spent most of his life in New York. He was always in the sportswear business. He played piano as a hobby. He served in the US Navy during the first World War, and was an active member of the 52 Club which entertained hospitalized war veterans every week.

Harold married Aline Mayer who had previously been married to Harvey Mayer. Harold legally adopted her children, Harvey and Aline, but they kept the Mayer name. She was very talented in many areas, including painting, sewing, cooking, etc. Harold and Aline lived in Pittsfield, Massachusetts for many years.

Harvey Mayer Jr. married Helene Weber. They lived in the Bronx and had a daughter, Wendy. Harvey served two years in the Army and was a mathematics programmer and computer operator. She was a kindergarten teacher.

Aline 'Bunny' (Mayer) Drescher was head of an elementary music program in a private school in Lenox, Massachussetts for 16 years and then head of lower school music in Hartford, Connecticut until she and her husband returned to Pittsfield, Massachussetts where he opened a psychiatric practice. She received her BA in music from the University of Hartford and attended the University of New York at Albany where she received her MA in social work in 1983. She was a social worker at the Berkshire Medical Center in Pittsfield for five years at the renal dialysis unit and then opened a private practice in psychotherapy in conjunction with her husband in Pittsfield. They retired in 1995, but now train their horses - three Haflingers (Austrian draft ponies) - and drive carts and carriages in parades and throughout the countryside. She and Alexander have three sons: Thomas, a movie music editor; Peter, who has his own company and writes music and sound for software and the internet, and William, who does the computer graphics for CBS News with Dan Rather.

Hazel Geigerman, a true descendant of a family of schoolteachers, taught in Public School #6 on Madison Avenue at 85th Street until her retirement. She inherited her mother's artistic talent, expressed through her sculpturing skill. Her works have been exhibited at the New School for Social Research. Hazel was associated with numerous and varied organizations during her career.

ebecca (Becky) Baum followed in the family tradition by teaching school. She never married. We got to know her well during her annual visits to us in Arverne. She was greatly attached to my father, her uncle Theodore, who was like a father to her. She was also very close to her cousin Mallie with whom she took trips abroad. When she retired from the school system, she devoted herself to the writing and translation of Braille books for the blind.

aisy (Baum) Levine was kindly, gracious and stoic. At the age of two she contracted what we now know was polio which left her with a terribly pronounced limp. At the time her family thought it was some sort of hip disease, but later her son Milton determined that it must have been polio. Daisy never permitted her infirmity to stand in the way of a normal, vital and fruitful life. She married David Levine, a reform Rabbi - a learned and lovable man. He was a scholar, idealist and organizer. With him, Daisy had five children in six-and-a-half years

David was an assistant to Dr. Stephen S. Wise, the incomparable orator, and a founder of the American Zionist Movement. Dr. Wise held a pulpit in Portland, Oregon, and when he was summoned to Europe he asked David to take over. They stayed in Portland for two years and then moved to Spokane, Washington, where the family remained until 1917. David was considered the leader of Reform Judaism in the northwest. On his return to New York he founded the Progressive Synagogue of Brooklyn. Unfortunately he died of cancer in 1926, at the early age of 49. People thought Daisy would never recover, but she did. She lived to a ripe old age, having brought up a fine family of four boys and one daughter: Marion, Milton, Edwin, Elroi and Arthur.

Marion (Levine) Gassner was always considered a wonderful daughter, of inestimable help to her mother, especially after her father died. She worked with children in a cerebral palsy center in Atlanta, Georgia and later lived in Laramie, Wyoming with her first husband, Bill Fisher. She had no children. Her second husband, Mordi Gassner, was a well known artist who, as a young man, was a set designer in Hollywood with Cecil B. De Mille and Douglas Fairbanks, Jr. He received two Guggenheim fellowships to paint in Italy and later worked for many years as a set designer for the Metropolitan Opera Company. His paintings have been exhibited at many institutions, including the Corcoran Gallery in Washington, the Brooklyn Museum of Art, and the Richmond Art Museum.

Milton Levine was a fascinating, multi-faceted personality. He married Jean Seligmann and they had two children, Carol and Ann. Milton died in 1993, Jean still resides in Manhattan. Following is a tribute written by one of Milton's cousins:

> My cousin the pediatrician: Writing about Milton Levine is like writing a column for Who's Who in America in which his name actually appeared for many, many years. Milton earned his MD degree from Cornell University in 1927. He was Associate Professor of Clinical Pediatrics at Cornell University Medical College, and Attending Pediatrician at New York Hospital. He has made significant contributions to the New York City Department of Health as Consulting Pediatrician, as Director of Research on Childhood Tuberculosis, and on the Commission for Study of Poliomyelitis. He was on the Advisory Committee for the White House Conference on Children and Youth from 1950-60, served on the Executive Board of the Louise Wise Adoption Agency, and was Consultant Pediatrician for the National Association for Psychoanalysis. Later he became Consulting Pediatrician at New York Hospital and Professor Emeritus of Clinical Pediatrics at Cornell.

> My cousin the author: Milton wrote over fifty articles in pediatric and other professional journals, and was the author of the volume Pulmonary Pediatrics. Many of his articles appeared in magazines such as Parents Magazine, The Ladies Home Journal, etc. Milton and his wife Jean wrote a syndicated newspaper column called Child Care for over ten years. They also published The Wonder of Life and A Baby is Born. In 1972, at the age of 70, Milton founded Pediatric Annals and was its Editor-in-Chief for the next 18 years, writing over 200 editorials.

> My cousin the commentator: From 1955 to 1956 Milton was the child care consultant on Margaret Truman's NBC radio program, and was a frequent guest consultant on television programs hosted by Martha Dean, Betty Furness, Arlene Francis and others. From 1968 to 1971 Milton had a nationally broadcast daily program on child care over WCBS radio.

> My cousin the family man: Not only did Milton resemble the Baums in appearance, but he inherited the Baum warmth and concern for family.

Milton's wife Jean (nee Seligmann), taught at the Bank Street Nursery School and was a partner in all facets of their life together. They wrote four more books: The Parents' Encyclopedia, Tommy Visits the Doctor, Your Overweight Child and Helping Boys and Girls Understand Their Sex Roles. Jean is also co-author of The Meaning of Music.

Carol (Levine) Paasche taught Early Childhood Education at Seneca College in Toronto, Ontario for 30 years. She has a BA from Antioch College and an MA from Harvard. Carol is now in private practice, specializing in parent/child relationships. Gottfried Paasche is a professor of Sociology at York University in Toronto. He is deeply involved in researching his family, prominent in the Resistance during World War Two.

The following is the obituary of Gottfried's mother Maria that appeared in the San Francisco Chronicle of February 5, 2000. She was obviously a very outstanding person and though not a blood relative, I believe that she deserves an honored place in our family. (EK)

"Maria Paasche, who helped Jews escape Nazi Germany and whose brothers and father tried unsuccessfully to keep Hitler from power, died January 21 in San Francisco of heart failure. She was 90. Mrs. Paasche, whose father was German General Kurt von Hammerstein-Equord, died at the Jewish Home for the Aged, where she lived for the last 2 1/2 years of her life. In the 129-year history of San Francisco's Jewish Home for the Aged, Mrs. Paasche was only the second gentile admitted - a testimony to her family's history of helping Jews in Germany.

'We felt honored and privileged to take care of someone like Maria,' said Sherie Koshover, the institution's director of community relations.

Mrs. Paasche was born outside of Berlin and raised in the city, where her father was chief of staff of the German Army from 1930 to 1933. An early opponent of Hitler, Hammerstein-Equord tried in January of 1933 to block Hitler's appointment as chancellor but was overruled by President Paul von Hindenburg. Historians have cited Hammerstein-Equord's effort as the last official resistance to Hitler's rise to power.

In 1939, Hammerstein-Equord repeatedly implored Hitler to visit the French front, where he planned to kill the German leader, but Hitler refused. Hammerstein-Equord, whose father-in-law was a German general, died in 1943 of cancer.

On July 20, 1944, two of Mrs. Paasche's younger brothers, Ludwig and Kunrat, participated in a plot to kill Hitler and form a new government. When the plot collapsed, the brothers went into hiding. Four members of Mrs. Paasche's family were arrested by the Gestapo in an attempt to make the brothers surface. Taken to concentration camps, the family members were freed by Allied forces at the end of World War Two.

Before the war, Mrs. Paasche and her two sisters helped Jewish friends and others hide and leave Germany. They also passed along intelligence information that was useful in helping people escape arrest.

'She had Jewish friends, which was remarkable for the daughter of a German military family that lived in Berlin,' said Gottfried Paasche, Mrs. Paasche's son. 'They actually lived in military headquarters, which is now a Resistance museum.'

In 1935, Mrs. Paasche married John H. Paasche, who had Jewish ancestry. After moving to Palestine, the couple returned to Germany, then fled to Japan because of Gestapo pressure. In 1948, the Paasches immigrated to the United States, settling in San Francisco. Mrs. Paasche worked as a cleaning woman and did other odd jobs to help support her husband and four children, all of whom were born in Japan.

A documentary about Mrs. Paasche's life, "Silent Courage: Marie Therese von Hammerstein and Her Battle Against Nazism," was completed last year. For most of her life, Mrs. Paasche had been reluctant to talk about her family's experiences in Nazi Germany.

'To the very end, she held onto (information) very closely, for fear it could damage people,' said Gottfried Paasche. 'That's what she had learned as result of her experiences. The interrogation by the Gestapo left a very strong mark on her."

Carol and Gottfried have three children, Franz, Denise and Sara.

Franz Paasche is a lawyer for Market Data Corporation. His wife Allison is also a lawyer but is currently at home raising their children Simone, Cecilia and Eleanor.

Denise Paasche and Tony Blofson celebrated their marriage by taking a one year trip around the world. Denise spent her youth in Toronto and attended Wesleyan University. After college she worked for a year and a half at Planned Parenthood in New Haven, Connecticut, then moved to San Francisco to live with her Paasche grandparents and do a training program in massage therapy before leaving for six months in China. Upon her return she attended medical school at the University of California, San Francisco, did a residency program in Family Medicine in Rochester, New York (where she met her husband-to-be Tony Blofson he was a year ahead of her). Together they joined a private group practice in Athol, a small town in rural Massachusetts where they have lived until this past summer. Their practice covers patients from birth (obstetrics) to death, and when not working or keeping up with their two young sons, Caleb and Ethan, they tend the vegtable garden, their beehives and sheep. They have recently moved to Brattleboro, Vermont and opened their own practice.

Sara Paasche-Orlow was born in Toronto, attended the Putney School in Vermont (as did her father, brother and sister), receiving a BA from

Oberlin College with a major in Public Policy and Women's Studies. She was a Wallenberg Fellow at the Hebrew University and also studied at the Pardess Institute of Jewish Studies, both in Jerusalem. She was ordained as a Conservative rabbi by the Jewish Theological Seminary of America in New York in 1996. Sara was a CLAL Fellow (National Jewish Center for Learning and Leadership) and worked as a Program Officer/Educator at the Jewish Life Network. She taught and gave workshops in the New York City area. The family has moved to Baltimore, Maryland where she continues working for the Jewish Life Network. She and her husband Michael have three children, Jonah Raziel, Lev Katzir and Gabriel.

Ann (Levine) Parker and her husband Ted live in Chevy Chase, Maryland. She received a BA in French from Oberlin College and an MA in Visual Limitation from Peabody College (Vanderbilt University). She taught brain injured and emotionally disturbed blind children until the birth of her first child, and then devoted the following 13 years to bringing up her children. She also taught music at their Temple's religious school. To ease herself back into the job market, she took a low-stress job as a proofreader, which she so enjoyed (the proofreading as well as the low stress) that she has remained there ever since. Ted has worked in theater management at the Kennedy Center, Washington Performing Art Society and at Ford's Theatre, had a home remodeling business, taught high school theater, worked with a graphic arts company and is now technical advisor to the theater program at Georgetown University. Ann and Ted have three children: Eva, Marion and Lillian.

Eva Parker shares her life with Brandt Passalacqua in Park Slope, Brooklyn, New York. She started her own web development company in 1994 and has been working out of her home ever since. Brandt is a musician whose bass and vocal duo, Basque, is recording its third album. Marion (Parker) Miller graduated in 1995 from the University of Maryland, College Park, with a BA in English, but started immediately on the career she had always desired: motherhood. Her husband Fred is Amtrak's System Safety Program Development Manager. They have four children: Laina (named after her great-great-great-grandmother, Lena Baum), Adina, Avraham (Avi) and Yael. Marion was always been involved in Judaism: during high school, she was NFTY Vice President for Religious Education, and in college she became observant. The family lives in Silver Spring, Maryland.

**Edwin Levine** received his MD from Cornell University Medical College. An internationally known specialist in chest diseases, he was Medical Director of the Department of Respiratory Care at the Edgewater Hospital in Chicago and ran one of the most active and best known hyperbaric chambers in the United States.

Edwin was Clinical Professor of Medicine at the Chicago Medical College from 1943 until 1986 and was Medical Director of the School of Respiratory Therapy of the Medical Careers Institute, as well as a fellow of the American College of Chest Physicians, and lectured in 38 countries.



Robert Reinhardt is employed as a truck driver. He was married to Aline. They had two sons, Robert Jr. and Douglas.


